Sealed or electronic bids must be submitted to the office of Ministry of Federal Affairs and Local Development, Office of the Phidim Municipality, Phidim, Panchthar by hand/courier or through PPMO website www.bolpatra.gov.np. on or before 12:00 hrs on **02 Apr. 2017**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 02 Apr, 2017 at the office of Ministry of Federal Affairs and Local Development, Office of Phidim Municipality, Phidim, Panchthar. Bids must be valid for a period of 120 (One Hundred Twenty) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, as indicated on table below
